# **Whitehaven Golf Club Membership – Terms and Conditions**

## General

Our membership year runs from 1st April each year to 31st March in the following year and is for a minimum of 12 months.

On payment of any joining fee and subscription the member will receive a membership card, bag tag and county card (where eligible).

Membership of the club entitles the member to play on the golf course on the days the membership type entitles them to. Members can also sign in 3 non-members during the entitled days at a reduced rate.

For insurance and health and safety reasons, all members must report to the clubhouse on arrival before playing golf (this also applies to members who have booked their tee online).

Joining fees and subscriptions are non-refundable and cannot be transferred to anyone else.

We reserve the right to close the course in full or in part or otherwise to restrict access onto the course at our sole discretion at any time and without notice. Any such closure or restriction shall not entitle any member to any refund of any fees, subscription or other sums paid.

We reserve the right to refuse admittance to any person as a guest to the club in our absolute discretion and without liability.

No person whose membership of the club has been terminated, or whose application for membership has at any time been refused, shall be admitted as a guest or visitor.

## Membership Card

Memberships include the provision of a member discount card. This card entitles the member to discounts at the clubhouse, pro shop and driving range. These discounts are subject to change without notice.

The card can only be used by the holding member and cannot be used for weddings, parties or functions.

The member card controls two separate levies (top-ups).

1. Clubhouse/Proshop – This levy can be used to purchase items in the clubhouse and Cumbria Golf Centre Ltd Pro shop. This levy can only be topped up at the clubhouse.  
This levy will expire two years after the date of top-up.
2. Range (ball) levy is a separate levy and can only be used to purchase range balls for use on the driving range. The balance is stored physically on the card and will be forfeited if the card is lost or stolen. Range levy can be topped up at the clubhouse or at The Golf Haven reception.

Clubhouse/Proshop levy can be transferred to range levy but range levy cannot be transferred to clubhouse levy.  
Neither club levy nor range levy can be used to pay for membership subscriptions.

Once a top-up has been made it can only be cancelled before its next use.

If your club membership is suspended for any reason, your levy account balance will not be available to use.

The membership card also allows access to the locker rooms in the clubhouse.

Replacement member cards due to damage or loss are subject to a £5 charge.

## Resignations

All membership resignations must be in writing.

Notice to leave no earlier than the next 31st March may be sent to us at any time throughout the membership year.

Any and all fees, subscriptions and other sums due must be paid in full before the notice of resignation becomes effective and a member is not entitled to a refund of any fees, subscriptions or other sums if notice to resign is given by that member to us at any point before the next 31st March.

The bag tag and county card must be returned to us on resignation.

Upon resigning, the levy balance will be available to use for two months after the end of the current membership year. However, no top ups can be made during that period. After the two months the card must be returned. Any remaining range levy can be transferred to a range card without charge.

In the event of resignation of membership within the membership year, for whatever reason, there will be no refund of membership subscription.
